### **V4 Law Student Summit**

# July 3-7 2024, Budapest

### **General Terms and Conditions**

The present General Terms and Conditions (hereinafter referred to as "GTC") govern the legal relationship between the applicant (hereinafter referred to as "Participant") and MCC for the V4 Law Student Summit event (hereinafter referred to as "Event") organized by the Mathias Corvinus Collegium Foundation (hereinafter referred to as "MCC") and run by the Mathias Corvinus Collegium University Program.

### 1. Establishment of the contract

- 1.1. The contract between MCC and Participant is concluded upon submission of the registration and acceptance of the application.
- 1.2. Deadline for application: 11:59 PM (CET), April 30, 2024

## 2. The Event Fee and its content

- 2.1. Attending the event is free of charge.
- 2.2. Following the transfer of the deposit, the MCC provides the following for the Participant:
  - provide accommodation, three meals a day,
  - professional programs.

### 3. Cancellation of the Event

- 3.1. Participants may cancel their participation in the Event by sending a written notice to the email address v4lawstudents@mcc.hu only. Participants cannot cancel their participation after June 20, 2024.
- 3.2. If a Participant is unable to attend the Event due to illness, he/she may cancel his/her participation without consequences.
- 3.3. If a Participant cancels participation in the Event after June 20, 2024őr, or fails to attend, except as provided in Section 3.2, the participant is liable to pay a penalty of €30.

## 4. Health, fire, and accident prevention standards

- 4.1. COVID19 measures: MCC will comply with and observe all requirements imposed by law or public law in the context of the Regulation. In addition, MCC may, within reason, impose additional protective measures that are more stringent than those required for the safety of its employees, volunteers, instructors, and Participants, and reserves the right to periodically review, modify and add new measures, subject to prior notice to the parties concerned. Should the Participant fail to comply with the protective measures prescribed by MCC, MCC shall be entitled to terminate the contract with immediate effect without any obligation to refund the participation fee.
- 4.2. Participants must comply with the fire safety regulations applicable in the Event area,

### 5. What to do in the event of an accident or illness

- 5.1. If the Participant has not declared at the time of registration the information necessary for the Event, MCC shall not be liable for any consequences that may arise.
- 5.2. The event is not open to patients with infectious diseases.
- 5.3. Based on the information provided at the time of application, MCC will ensure that any Participant with food sensitivities is properly catered for.
- 5.4. MCC is not responsible for any illnesses caused by the consumption of food imported from elsewhere.



## 6. Prohibitive provisions

- 6.1. It is strictly forbidden to bring into the Event area any stabbing or cutting instruments or any other objects that may endanger the safety of the Participant or other Participants.
- 6.2. The use of drugs is strictly prohibited at the Event and during the Event.
- 6.3. The Participant shall not engage in any conduct dangerous to life, limb, health, or property of others.
- 6.4. It is prohibited to damage the accommodation provided during the Event or the equipment and facilities located in the Event area. Participants shall be liable to pay compensation for any damage caused.

#### 7. Valuables

7.1. MCC is not responsible for valuables brought into the Event area.

# 8. Image and sound recording

8.1. By concluding the contract, the Participant acknowledges that MCC may use and publish images, video, and audio recordings of the Participant during the Event, which may be used by MCC for its activities and the promotion of the event, and may publish and display them on MCC's communication platforms (Youtube, Instagram, Facebook and <a href="https://www.mcc.hu/">https://www.mcc.hu/</a> websites) on posters promoting the program, in recruitment materials, and presentation materials.

## 9. Vis major

9.1. In the event of force majeure, including in particular: acts of war, insurrection, revolution, civil war, terrorist attack, radioactive contamination caused by nuclear material, shock waves caused by flying objects, or any act of God (flood, avalanche, landslide, earthquake, volcanic eruption), MCC shall not be liable for any damage.

## 10. Cancellation, withdrawal

- 10.1. MCC may terminate this contract with immediate effect if the Participant violates the rules governing his/her participation in the Event, or if his/her conduct significantly endangers the successful holding of the Event, the life, physical safety, or health of the participant of the Event, or causes damage to the Event venue or its equipment through no fault of his/her own or commits a criminal offense/violation of the rules during the Event. MCC may also claim compensation for damages in the event of termination of the contract on these grounds.
- 10.2. Cancellation of participation in the Event shall be deemed to be a withdrawal from the contract, which shall be subject to the provisions of clause 3.
